# FIRST AMENDMENT TO DECLARATION OF CONDOMINIUM FOR OPUS MYERS PARK CONDOMINIUM

THIS FIRST AMENDMENT TO DECLARATION OF CONDOMINIUM FOR OPUS MYERS PARK CONDOMINIUM (this "First Amendment") is made this 22 day of July, 2019, by OPUS MYERS PARK, LLC, a North Carolina limited liability company ("Declarant"), and by OPUS MYERS PARK CONDOMINIUM OWNERS ASSOCIATION, INC, a North Carolina nonprofit corporation ("Association").

### **RECITALS**

- 1. <u>Incorporation of Recitals; Defined Terms</u>. The above Recitals are hereby incorporated herein by this reference. Capitalized terms used but not defined herein shall have the meaning(s) attributed to the same in the Declaration.
- 2. Amendment. With the filing of this First Amendment, along with the related filing of revised page 3 (of 29) of the Condominium Plans, entitled "Parking Level", by DAS Architecture, Inc., and recorded under the name of the Condominium in Unit File 1061 at Page 31 , Mecklenburg County Public Registry, the Declarant and Association hereby reallocate parking spaces 50 and 51 from the category "common elements" to become "limited common elements", and in substitution thereof, allocate parking spaces 25 and 26 from the category "limited common elements" to become "common elements."
- 3. <u>Effect of First Amendment</u>. Except as specifically amended herein, the Declaration shall remain in full force and effect.
